- **Note 1.** Proxy Forms may be used. They can be obtained from the Trust Office (by email or physically by arrangement) and the completed forms must be lodged at the Trust Office (in hard copy or by scanned document) by 5pm on 3rd October 2025.
- **Note 2.** Members wishing to see a copy of last year's minutes beforehand should contact the Trust Office.
- **Note 3.** Summarised accounts are available on the event, via the office, and online at the RWT website. Copies of the audited Full Financial Report will be available thereafter and at the AGM. Members wishing to see a copy beforehand should contact the Trust Office.
- **Note 4.** The Hon. Julian Gibson-Watt was re-elected as President at the 2022 AGM for a 3-year term, which now expires. He has offered himself for re-election. MT Gibson-Watt, Lord Guy Milford and Elizabeth Passey were elected as Vice-Presidents at the 2024 AGM for a one-year term and have offered themselves for re-election. Council proposes that Julian, MT, Guy and Elizabeth are re-elected accordingly for three years, until the 2028 AGM.
- **Note 5.** Council has nominated Sue Holden as Chair for the forthcoming year. Jen Newman is nominated as Vice-Chair. Edmund Hayward, Hon. Secretary, and Bill Stow, Hon. Treasurer, have been nominated by Council to continue in post for the forthcoming year. Sue, Jen, Edmund and Bill have indicated their willingness to stand for election.

The following Member retires by rotation: Richard Thomas. He has indicated his willingness to stand for reelection.

All other members of Council are continuing in post.

- **Note 8. TEMPORARY NOTE**: At the request of the Royal Society of Wildlife Trusts, all UK Wildlife Trusts have been requested to update their governing documents to take account of recent practical (e.g. in electronic communications) and legislative changes. RWT has actively participated in this exercise and our proposed amendments are currently being reviewed by the Charity Commission. The Trust hopes to receive their approval of the changes soon, whereupon this note will be updated, giving the exact wording of the proposed resolutions, and providing further explanatory notes.
